The Oral Health Fall Forum is scheduled for Friday, November 30<sup>th</sup> at the Holiday Inn in Concord. Other venues considered but more expensive were the Grappone Conference Center and Mills Falls Church Landing in Meredith. Stephanie Pagliuca informed the group of recent improvements/renovations of the lobby and ballroom of the Holiday Inn.

### Review Agenda

- Concept and title, “On the Frontlines: Innovative Oral Health Programs and Community Solutions” emphasizing what’s new in community-based oral health services was accepted unanimously.
- As in previous years, the forum will be a full day event starting with a healthy breakfast. We will need to add additional sponsors.
- Opening remarks from Helen Taft
- In memoriam: In 2017, we did segment honoring the life of Lyndsay Joseph. This year we would like to mention the loss of Cleo Castonguay, president of St. Vincent de Paul Community Assistance Center who died in May; Susan Cote who was program coordinator for the Sadie and Harry Davis Foundation, and initiated the program, From The First Tooth in Maine who died in August, and Tom Taylor, Primary Care Integration Coordinator at Alaska Primary Care Association who died way too young in April.
  - Offer a “moment of silence for Cleo, Susan and Tom as well as others whom we have lost in the last year”.
  - Stephanie Pagliuca volunteered to provide the statements and suggested that there be a poster listing those we have lost where participants can add names of others.
- Keynotes/moderator: two national speakers are on deck and are scheduled in the morning.
  1. Originally Steve Geiermann who is with the ADA working on their community access program agreed to do an overview (we like to have someone from the ADA – organized dentistry -give an overview) and act as a moderator. Something came up to and he arranged to have Jane S. Grover, DDS, MPH speak in his place. Dr. Grover is the Director of the Council on Advocacy for Access and Prevention of the ADA each year. She is to open to provide an overview of pathways to care. She is a great speaker and will do a good job provided she is given clear direction as to what we would like her to address. She can help transition to the next panel.
  2. Yasmi Crystal, DMD is a Clinical Professor of Pediatric Dentistry at New York University College of Dentistry. She works a lot with Dr. Neiderman on SDF, and evidenced based

community dentistry. Need to work with her on the title of her presentation. She is a key researcher on the effectiveness of SDF in caries management and factors affecting it.

- Looking at the workforce models and how they apply in NH.
  - Hope, Stephanie will give us an update on the HRSA Workforce Grant; talking about CPHPD, EFDA. Met EFDA requirement at NHDS meeting so they don't have to do a large presentation and can focus on CPHPD but should mention EFDA in community centers. Stephanie will present on the overall goals of the project and Hope will focus on the clinical roles.
  - Need to figure out the time involved.
  - (EFDA table and panel – who would lead this (perhaps someone from Goodwin Community Health or NHTI)? – EFDA Stephanie will get the name; or maybe Lynnea Adams. Recommended Casey McNutt, Expanded Function Dental Auxiliary at Interlakes Family Dental Center.
  - Community Dental Health Coordinator, Mike Auerbach, getting ready to launch something in New Hampshire. What's happening, what's the goal and hope for the workforce model,
  - Community Health Worker not sure where and how. North Country Health Consortium on seniors and chronic health care. Annette Cole had some funding for care coordination and did training — they have one CHW with specialized dental training. The AHECs (Annette & Nancy – North/Paula Smith - South) are working on identifying individuals appropriate to sit on the panel and to host a round table.

**Side note:** At the DQ National perhaps we could pose the question “how to better engage organized dentistry” in our Forum. How do we weave them into the discussions? Opportunity to point people to the afternoon roundtables.

Two panels (in this order because once the SUD discussion began it would be difficult to transition

    - The developmental disability community is getting strong and assertive in their voice for a dental benefit.
  - Are their dentists or dental models that we can showcase? Need to explore this.
    - Kris Blackwelder maybe doing nursing home but works with children. Earle Simpson, Roger Achong, Jeff Vachon
  - Move HPV Toolkit topic to roundtable (initiative led by Jenna Schiffelbein that created, piloted and implemented the toolkit) – also have a table
