Unifying Messages – Common Agreement

## NH Oral Health 2014 Project Overview

To engage a broad-spectrum oral health stakeholder group to examine, analyze and identify an infrastructure system to deploy public health dental hygienists into underserved areas.

## **Key Points**

- •NH has no systemic state or county-based framework for public health service delivery.
- •However, existing infrastructure systems that are used for other purposes might support PHDH deployment including the Public Health Networks (PHNS), community health centers (CHCs), counties, and other systems that may be identified during the project.

## Key Strengths

- NH public health supervision in the dental rules See Rule 302.02(d) and 402.01(c)
- NH Certified Public Health Hygienist (RSA 317-A:21-e)
